The Subadar exhibited conspicuous gallantry in the fight at Jass camp on the 26th April 1898, on which occasion he, with No. 1 Section and the maxim Section, formed up on the left of the firing line, which was wavering, and by a steady conduct of fire, enabled the centre to rally and the flank sections of the contingent to cope successfully with the enemy's main counter attack.

He also distinguished himself as a leader in the defence of Mruli Post on the 30th May 1898, and was specially commended for his gallantry.

Jemadar Kalu Majhi took part in the frontal attack on the enemy's position, and exhibited much coolness and daring in leading on his men. During one period of the action he bravely stood by a wounded man under one of the stockades, fully exposed to the enemy's fire, until the stockade was captured.

P. G. Griffin of his regiment, whose horse had been shot and who was attacked by the enemy.

No. 697, LANCE DAFADAR IMAM ALI KHAN, Ist Bengal Lancers—was admitted to 3rd class, for conspicuous gallantry in the field at Tungchow on the 12th August 1900, on the march to Pekin, when he, though unarmed, was mainly instrumental in effecting the capture of three Chinese junks laden with powder and guarded by 30 or 40 men.

SUBADAR KAMARDIN.—For conspicuous gallantry in action against the Chinese at Tiechaying, North China, on the 12th December 1900, when he, supported by only one man, forced the door of a walled enclosure held by enemy, and advancing alone into the courtyard shot down two of the defenders, thereby creating a diversion in favour of his comrades, who were storming the enclosure walls.

No. 2029, Private DOST MUHAMMAD, and No. 2448, Private AKBAR KHAN.—For conspicuous gallantry in action against the Chinese at Tiechaying, North China, on the 12th December 190), on which occasion they scaled the walls of an enclosure held in force by the enemy and jumped into the courtyard in support of their British officers who had preceded them.

DAFADAR DAL SINGH, Jodhpur Imperial Service Lancers, was admitted to the 3rd class for conspicuous gallantry in action near Shanhaikwan, North China, on the 12th January 1901, on which occasion he, with only three men, effectually protected a foraging party of his regiment against a superior body of Chinese, until relieved.

Browning and Sepoy Ganda Singh, who had been shot down. In the performance of this gallant action he was himself severely wounded.

No. 942, NAIK DIAL SINGH. For conspicuous gallantiy in action at Tai-Tao-Ying. North China, on the 20th April 1901. on which occasion under a close and heavy rifle fire, he endeavoured to bring in the body of Major Browning who had been shot dead, notwithstanding that immediately before Sepoy Ganda. Singh had been killed and Sepoy Lehna Singh wounded in making a similar attempt.

No. 1706, SOWAR DOST MUHAMMAD KHAN 18th Bengal Lancers, was admitted to the 3rd class for conspicuous gallantry in action at Sanna's Post, South Africa, on the 30th March 1900, on which occasion he, under a heavy rifle fire at close range, went with Lieutenant A.G. Maxwell to the assistance of atrooper of Roberts' Horse, whose horse had been killed, and helped him to mount and retire with the rest of the corps,

A heavy fire was opened on them from the towers, and both the British officers and several men fell wounded. No. 3322, SEPOY SUNDAR SINGH.—For conspipicuous gallantry at the Tiarza nullah on the 26th November 1901, on which occasion he, of his own accord and on his own initiative, crossed a fire-swept zone, and fearlessly averting possibly serious loss of life.

No. 3259, Sepoy Jhanda Singh.—For conspicuous gallantiy at the Tiarza nutlah on the 26th November 1901, when he, of his own accord and on his own initiative, rose from under cover and, under a heavy fire from the enemy, helped in causing the firing of our own men to be discontinued and thereby averted serious loss of life.

# 29th Punjab Intantry.

No. 2404, HAVILDAR SHER BAZ.—For conspicuous gallantry during the retirement from Guri Khel Hill on the 7th December 1901, on which occasion he bravely returned and assisted in bringing in the body of another havildar of the regiment, which, though hard pressed, he continued carrying throughout the retirement, notwithstanding a heavy fire from the enemy at a distance of only forty yards.

# 45th (Rattray's) Sikh Infantry.

SUBADAR ALA SINGH.—For conspicuous gallantry during the rear-guard action near Ahmedwam on the 5th January 1932, on which occasion he set his men a fine example of gallant conduct, and, at great personal risk, brought wounded men under shelter.

No. 3188, HAVILDAR WASSAWA SINGH, and No. 3792, SEPOY RODHA SINGH.—For conspicuous gallantry in the assault of a hill at Umar Raghza on the 5th December 1911, on which occasion these two men

were the first to reach the summit with Captain Mc-Vean, arriving there simultaneously with a party of the enemy from the opposite side, whom they immediately drove off, and though Captain McVean was severely wounded, they retained possession of the hill until support arrived.

## 1st Battalion, 2nd Gurkha Rifles.

No. 2493, Lance-Havildar Bahanbir Rana.— For conspicuous gallantiy in the Shuktu valley on the 3rd January 1902, and Khar Kach on the 5th idem, on both of which occasions he proceeded far in advance, under heavy fire, to the aid of wounded comrades, one of whom he personally carried into a place of safety.

No. 3045. RIFLEMAN MANSUR RANA.—For conspicuous gallantry near Khar Kach on the 5th January 1902, in returning to the aid of a comrade who had fallen wounded in a nullah, but who was unfortunately cut up by the enemy before assistance could reach him.

#### 4th Sikh Infantry.

JEMADAR KAMAL KHAN.—For conspicuous gallantry at Waladi Khan on the 6th January 1902, on which occasion he, at great personal risk, led a small party into the building from which the late Captain Down, Political Officer, had just been shot down, and which he knew to be occupied by several fanatics.

## 1st Punjab Infantry.

No. 1337, SEPOY MIR ABAS, No. 1330, SEPOY GULAB SHAH, and No. 730, SEPOY BADAN SINGH—For conspicuous gallantry at Kot Shingi on the 25th November 1901, in going back under a heavy fire and at great personal risk, and bringing off the body of Subadar Muhammad Gul, who had been killed in covering the withdrawal of a picquet.

# MAHSUD-WAZIRI BLOCKADE, 1901.

HAD SUBADAR MUHAMMAD GUL, and No. 4339, HAVILDAR MIR MUHAMMAD, of the 1st Punjab Infantry, survived, the distinction of the 2nd class would have been conferred on them in consideration of the conspicuous gallantry and heroic devotion to duty displayed by them on the occasion of the retirement from Kot Shingi, when they lost their lives in covering the retirements of the picquets. Their widows were admitted to the pension of the 3rd class.
